

## **PEVALIN RESOLUT**

### Properties

*PEVALIN RESOLUT* is an oil-in-water emulsion.

*PEVALIN RESOLUT* cleanses the skin deep into the pores, gently, and offers lasting skin protection and excellent refatting.

*PEVALIN RESOLUT* easily removes heavy soiling such as lubricants, dyes, oils, fats, tar, bitumen, cement, ink, wax, soot, etc.

### Composition

*PEVALIN RESOLUT* is based on raw materials that are dermatologically and toxicologically safe.

*PEVALIN RESOLUT* contains gentle natural oils and soothing lanolins. Water-insoluble, fragrance-free cleansing components integrated in the oil-in-water emulsion ensure gentle removal of the soiling. There is no direct contact between the dirt-removing substances and the skin. The surfactants are biodegradable and fulfil the requirements of the OECD screening test.



*PEVALIN RESOLUT* contains gentle synthetic abrasives that enhance the cleansing effect. These abrasives do not block waste pipes.

*PEVALIN RESOLUT* is silicon-free.

*PEVALIN RESOLUT* has been dermatologically tested.

*PEVALIN RESOLUT* is proven due to many years' use in practical application.

### Application

Rub *PEVALIN RESOLUT* (without water) well into dry and dirty hands until the dirt is completely dissolved. Rinse off with water or wipe off with a towel.

*PEVALIN RESOLUT* cleanses the skin deep into the pores without using water.

A little *PEVALIN RESOLUT* goes a long way. Approx. 3 ml (one dose from the dispenser) is sufficient to clean your hands thoroughly.

# Skin cleansing

## Extreme soiling

### Product description

White to light beige oil-in-water emulsion in a cream paste.

Contains PE abrasives.

pH-value: 7.5 - 7.9

Density: Approx. 0.83 g/cm<sup>3</sup> (20° C)

### Statutory requirements

*PEVALIN RESOLUT* is subject to the German Cosmetics Ordinance (KVO) and the Foodstuffs and Commodities Act (LMBG). All cosmetics products in the *PEVA* range are manufactured in accordance with GMP (Good Manufacturing Practice) and are subject to microbial quality assurance checks.

### Storage information

*PEVALIN RESOLUT* can be stored in closed original containers at room temperature for at least 18 months and in tubes for at least 30 months. The contents must be used within 12 months of the tube being opened.

*PEVALIN RESOLUT* must be protected against frost.

### Skin care information

When working with noxious substances, a suitable skin protection agent should be applied before starting work (e.g. *PEVAPERIM* universal skin protection lotion). After finishing work, a suitable hand care agent should be rubbed into the skin regularly in order to aid regeneration (e.g. *PEVALIND* skin care lotion, rich in active ingredients).
