Properties

PEVASCHUTZ is a non-fatty skin protection lotion that is dispersed easily and is quickly absorbed.

PEVASCHUTZ protects skin when working with non-aqueous substances.

PEVASCHUTZ prevents many substances coming into contact with the skin and stops soiling from penetrating deep into the skin.

PEVASCHUTZ eases cleaning through dirt emulsifying ingredients. In many cases, cleansing agent can be dispensed with, thereby making life easier for skin.

PEVASCHUTZ, when applied consistently, can prevent skin-related illnesses and downtimes in the factory.

PEVASCHUTZ protects skin against oils, fats, lubricants, tar, bitumen, varnish and paints, cement, lime, other dusts, dyes, sealants, etc.

Composition

PEVASCHUTZ is based on renewable raw materials that are dermatologically and toxicologically safe. The protective function is achieved primarily by using special film-forming substances.

PEVASCHUTZ contains moisturisers and water-soluble substances that care for the skin and protect against noxious substances.

PEVASCHUTZ is silicon-free.

PEVASCHUTZ is pH-neutral.

PEVASCHUTZ has been dermatologically tested.

PEVASCHUTZ is proven due to many years' use in practical application.

Application

Make sure your skin is clean and dry and then carefully rub in **PEVASCHUTZ** before beginning work (particularly into the bed of your nails).

Skin is cleaned by adding a little water.

After the soiling has been dispersed, rinse well with water and then dry off.

If soiling is heavy, you should use a suitable hand cleaner.

Statutory requirements

PEVASCHUTZ is subject to the German Cosmetics Ordinance (KVO) and the Foodstuffs and Commodities Act (LMBG).
All cosmetics products in the **PEVA** range are manufactured in accordance with GMP (Good Manufacturing Practice) and are subject to microbial quality assurance checks.

Storage information

PEVASCHUTZ can be stored in closed containers at room temperature for at least 24 months.

Skin care information

When working with non-aqueous substances, a suitable skin protection agent should be applied before starting work (e.g. **PEVASCHUTZ** universal skin protection lotion).

Depending on the type of soiling, a suitable hand cleansing agent should be applied (e.g. **PEVASTAR** for medium to heavy soiling or **PEVALIN SPEZIAL** for extreme soiling).

After finishing work, a suitable hand care agent should be rubbed into the skin regularly in order to aid regeneration (e.g. **PEVALIND** skin care lotion, rich in active ingredients).

- **PEVAMAT SF** - stainless-steel dispenser for 2 l soft bottle, lockable
- **PEVAMAT UKS-2** - plastic dispenser for 2.2 l cartridge
- **PEVA** - 3-pack dispenser set (for one 1 l bottle of skin protection, one 1 l bottle of skin care and one 3 l can of hand cleanser) with wall bracket.
